**NOTICE OF REVIEW OF POLLING DISTRICTS, POLLING PLACES & POLLING STATIONS**

**NOTICE IS HEREBY GIVEN** that Somerset Council is conducting a review of all polling districts, polling places and polling stations within its administrative area.

The Acting Returning Officer for the Parliamentary Constituencies of **Bridgwater, Frome and East Somerset, Glastonbury and Somerton, Taunton and Wellington, Tiverton and Minehead, Wells and Mendip Hills and Yeovil** will make comment on the Council's proposals and those representations will be published on the Council's website in accordance with the timetable set out below.

Electors within the administrative area of Somerset Council or the Parliamentary Constituencies of **Bridgwater, Frome and East Somerset, Glastonbury and Somerton, Taunton and Wellington, Tiverton and Minehead, Wells and Mendip Hills and Yeovil** may make representations.

The Council welcomes the views of all residents, particularly disabled residents and any person or body with expertise in access for persons with any type of disability, on its proposals and the (Acting) Returning Officer's representation or any other matter relating to the electoral process.

Persons or bodies making representations should, if possible, give alternative places that may be considered for use as a polling station.

The consultation period will last from **23 July 2026 until 3 September 2026**.
